DRAWDOWN ~ 15 OCTOBER 07 4-FEET

Wow! It's hard to believe that summer is over, that school and has begun and the holidays are just around the corner. We hope that everyone had a wonderful summer!!

DRAWDOWN

This year's drawdown (4-feet) began on October 15, 2007. At the August 2007 meeting, the membership voted for a "stepped" refill (i.e., 2-feet at a time). Refill will not start until we have received notification from Lycott that a hard freeze has occurred. Once this information has been received from Lycott, the lake level will be allowed to rise 2-feet and be held there until approx. March 1, 2008.

It is hoped that the stepped refill will protect resident's property from the destructive ice, while still providing adequate weed control. The request for drawdown and a stepped refill was presented to the Conservation Commission on September 19, 2007. The 4-foot drawdown and stepped refill was approved at that time.

PRIVATE ROAD PETITIONS

As you may recall, at the Annual 2006 Town Meeting, Article 32 was passed which requires 51% of the residents on private roads to petition the town to maintain the roads (e.g.,

patch work, sweeping, plowing, etc). Please note that these petitions are **different** from the ones which were signed to allow the installation of the sewers lines. The sewer petitions provided the town with an *easement* to install the sewers. The current petitions give the town legal permission to perform maintenance on private roads. To date the following roads still need signatures: Glen Echo Shore Rd, Stephen Dr, Lakeview Dr, Stevens Park Rd, Highland Ave, Westview Dr, and Brookside Rd. All other roads have been completed and submitted to the highway department.

In an effort to help the residents around Glen Echo Lake, GEIA obtained the appropriate road petitions in October 2006 for people to sign. There have been numerous opportunities for residents to sign the petitions, from Association meetings, to various volunteers walking door to door. It is essential that these petitions be signed and submitted for each private road as the town WILL NOT perform maintenance on ANY private road without them.

The Association is looking for volunteers from the roads listed above to complete the petition process. If you are interested in

GEIA PROPERTY TRASH & PARKING

In an effort to curtail parking on the property, boulders have been installed which bisect the property from the road down towards the water preventing parking on the property but not inhibiting other activities. Several signs have been placed on the property indicating the property's use, including, but not limited to, property hours and trash removal.

In addition, we encourage everyone to maintain their docks. Over the summer pieces could be found floating in the lake. This type of debris poses hazards to boaters and skiers alike and could cause serious injury. Please remember to check your dock and make any repairs necessary prior to the new boating season. Thank you!
